ABOUT US:

Marin County Parks offers an extensive system of regional and community parks, open space preserves, and trails for public use and enjoyment. The Department consists of two divisions: The Parks and Landscape Division and the Marin County Open Space District (MCOSD). The Department is responsible for planning, acquiring, and managing the County's open space system, which includes more than 16,000 acres of open space and more than 250 miles of public trails, as well as the County's park system with five regional parks, eight neighborhood parks, and six paved multi-use paths. In addition, the Department works closely and collaboratively with private organizations and public agencies within the county that manage and preserve open space lands, parks, and protected environmental sanctuaries including Marin Municipal Water District, Golden Gate National Recreation Area, California State Parks, and National Marine Sanctuaries. The County's park and open space systems are enjoyed by millions of visitors annually.

ABOUT THE POSITION:

Don't miss this unique opportunity to make a positive environmental impact on the habitat restoration of Marin County's Ring Mountain Open Space Preserve. This is your chance to collaborate with The Nature Conservancy on this multi-year grant funded project to restore and maintain the natural beauty of this special place and to preserve it for the enjoyment of future generations.

The Resource Specialist GIS will take the lead in overseeing, implementing, and monitoring public access and habitat restoration projects. They will need to be able to identify and manage invasive weeds; map and monitor rare plants; and plan and manage public outreach programs.

Our Highly Qualified Candidate: will possess lead experience in land stewardship, including road and trail management, habitat restoration, and public outreach programs. They will have a strong foundation in:

- The ability to manage natural resource projects
- Organizing, advertising, and holding volunteer and community outreach events that are intended to increase public awareness about natural resources on public lands
- Understanding ecological principles related to sensitive plant and wildlife species and their habitat
- Scientific knowledge of the native and non-native flora of Marin County, including the ability to identify, map, and monitor these flora using standard mapping and monitoring protocols
- Creating, maintaining, and updating maps and GIS data in ArcGIS

Any combination of education and experience that would provide the knowledge and skills listed below. Typically, equivalent to graduation from a four-year college or university with a major in geography, biology, natural sciences, resource management, forestry, wildlife management or a related science and two years of professional experience which includes development and implementation of resource management projects with an emphasis on GIS or experience in digitizing data or working with ortho-photography and/or automated geographic information databases.

Substitution: Additional experience in geography, biology, natural sciences, resource management, forestry, wildlife management or a related science can be substituted for the four-year degree on a year-for-year basis

ABOUT THE PROCESS:

Testing and Eligible List: Depending on the number of qualified applications received, the examination process may consist of a highly qualified application review, supplemental application screening, online assessment, written examination, oral examination, performance examination, or any combination to determine which candidates' names will be placed on the eligible list.
