FY 2022/2023 Local Court Crisis Intervention Program Grant (LCCIP)

Introduction

The Local Court Crisis Intervention Program Grant (LCCIP) furthers the U.S. Department of Justice, and the Missouri Department of Public Safety's mission by assisting local efforts to prevent or reduce crime and violence, with a particular focus on gun related violence and the programs and initiatives that target the risk factors that are likely to lead to this kind of violence. Funding for this program is provided from the Byrne State Crisis Intervention Program (SCIP) Grant.

The SCIP Program is administered by the U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), and Bureau of Justice Assistance (BJA). The Missouri Department of Public Safety (DPS) is the governor-appointed State Administering Agency (SAA) of the SCIP funds, and will continue to subaward the "less than \$10,000" SCIP allocation to eligible local/state courts that provide criminal justice and civil justice services.

Program Description

The Missouri Department of Public Safety's primary objective in awarding LCCIP funding is to partner with courts to fund local efforts to prevent or reduce crime and violence with particular focus on gun related violence and programs and initiatives that target the risk factors that are likely to lead to violence.

As authorized by the Bipartisan Safer Communities Act of 2022, SCIP provides formula funds to implement state crisis intervention court proceedings and related programs or initiatives, including, but not limited to:

• Specialized court-based programs such as drug, mental health, and veterans treatment courts, including those that specifically accept clients with firearm related violations:

- Violence recovery courts that connect clients in crisis with community resources
- Technology analysis, or information-sharing solutions for ensuring law enforcement, probation, prosecutors, the courts, and public defenders are informed when a prohibited person attempts to purchase a firearm
- The cost to develop and implement systems to assess the risks and needs of clients and connect them to critical services to mitigate their risk of violence and enhance their access to effective interventions (i.e, validated violence risk assessment tools, service case management, and navigation programs)
- Expanding the capacity of existing drug, mental health, and veterans treatment courts to assist clients who are most likely to commit or become victims of crime, including those involving gun related violence

Funding for the LCCIP Program utilizes the "less than \$10,000" allocation awarded to the Missouri Department of Public Safety.

Eligible Applicants:

Any state or local agency within Missouri may apply for LCCIP funding for its local/state court as long as the agency meets the eligibility requirements.

Any state or local agency not listed on Appendix A is an eligible jurisdiction.

Ineligible Applicants

- Applicants that are not applying on behalf of a Missouri state/local court that provides criminal justice and civil justice services for the eligible jurisdictions.
- Units of Government included on the Appendix A "List of Ineligible Applicants" are ineligible to apply to the Missouri Department of Public Safety for the 2022/2023 LCCIP funding opportunity. (Agencies listed on Appendix A were listed on the 2021 and/or 2022 Missouri Local JAG Aallocations list from DOJ)

An 8-hour day may include preparation, evaluation, and travel time. Compensation for individual consultant services is to be reasonable and consistent with that paid for similar services in the marketplace.
